By certification or on oath, the complainant says that to the best of his/her knowledge, information and belief the named defendant on or about 03-25-2010 in **FAIR LAWN BORO**, **BERGEN** County, NJ did: WITHIN THE JURISDICTION OF THIS COURT, COMMIT THE ACT OF INTERFERENCE WITH CUSTODY, SPECIFICALLY BY TAKING O.B (PRESENT AGE 27 MONTHS), TO ISRAEL ON MARCH 25, 2010, AND FAILING TO RETURN THE MINOR CHILD, WITH THE PURPOSE OF CONCEALING THE MINOR CHILD AND DEPRIVING THE FATHER OF CUSTODY AND PARENTING TIME WITH THE MINOR CHILD, IN VIOLATION OF N.J.S.A. 2C:13-4A(1), A CRIME OF THE 2ND DEGREE

WITHIN THE JURISDICTION OF THIS COURT, COMMIT THE OFFENSE OF CHILD CUSTODY INTERFERENCE, SPECIFICALLY BY DETAINING "O.B. (AGE 27 MONTHS), AFTER HAVING ACTUAL KNOWLEDGE OF ACTIONS ORDERED BY THE HONORABLE BONNIE J. MIZDOL, PJFP, DEMANDING THE RETURN OF THE MINOR CHILD, DID DETAIN THE CHILD OUTSIDE OF THE UNITED STATES FOR THE PURPOSE OF DEPRIVING THE FATHER, SHARON BEN-HAIM, WITH CUSTODY AND PARENTING TIME, WITH INTENT TO EVADE THE JURISDICTION OF THE COURTS OF THIS STATE, IN VIOLATION OF N.J.S.A. 2C:13-4A(2), A CRIME OF THE 2ND DEGREE.
